LTIP units are generally not convertible until two years from the date of the grant.

 - (6) LTIP Units vest in three equal installments beginning on February 10, 2017 and have no expiration date.
- LTIP Units awarded in lieu of performance share plan units and upon meeting the performance-based conditions, pursuant to Rule
- (7) 16b-3(d) of Section 16b of the Securities Exchange Act of 1934. LTIP Units are awarded according to the terms described in footnote 4 and have no expiration date.
