- Settlement of restricted stock units ("RSUs"). On December 21, 2012, the reporting person was granted 240,000 RSUs, vesting in two installments as follows: 100,000 on June 30, 2013 and 140,000 on December 15, 2014. Each RSU represents a contingent right to receive one share of Allison Transmission Holdings, Inc. ("ALSN") common stock.
- (1) Represents shares withheld by ALSN to satisfy tax withholding obligations on the vesting of RSUs.
 - (2) Settlement of dividend equivalent rights ("DERs"). The DERs accrued when and as dividends were paid on ALSN common stock and vest proportionately with the RSU to which they relate. Each DER is the economic equivalent of one share of ALSN common stock.
 - (3) Represents shares withheld by ALSN to satisfy tax withholding obligations on the vesting of DERs.
