On August 13, 2014, CHC Group Ltd. (the "Company") issued a press release announcing that the Company plans to issue its financial results for the first quarter of fiscal year 2015 ended July 31, 2014 after market close on Monday, September 8, 2014. The Company also announced in the press release that William Amelio, the President and Chief Executive Officer of the Company, and Joan Hooper, the Chief Financial Officer of the Company, will present at 4:25 p.m. Eastern Time on Wednesday, September 3, 2014 at the 2014 Barclays CEO Energy-Power Conference, which will take place at the Sheraton Times Square in New York City. In addition, the Company announced in the press release that it will hold its first analyst meeting since its initial public offering on Thursday, October 2, 2014 in New York City.
