On May 8, 2018, Altisource S.à r.l., a wholly owned subsidiary of Altisource Portfolio Solutions S.A., and New Residential Investment Corp. entered into an amendment (the “Amendment”) to the previously disclosed non-binding letter of intent dated August 28, 2017 to enter into a Services Agreement (as previously amended, the “Services LOI”), as the parties continue to negotiate the Services Agreement. The Amendment extends the term of the Services LOI through June 15, 2018, which period will be automatically extended through June 30, 2018 if the parties are continuing to negotiate in good faith.
