The registrant is unable to file its Form 10-K for the fiscal year ended June 30, 2012 by the prescribed date of September 28, 2012 as it has not yet finalized an agreement with its mortgage holder on certain financial covenants not being met. Without any agreement, the covenants would require the entire mortgage balance, reflected in the Company's current and long term liabilities, be classified as current in its entirety as it becomes "callable" despite the debt obligations fully being met on a current basis (is a performing loan to the mortgage holder). The registrant expects the Form 10-K to be filed on or prior to the prescribed extended date.
