On July 21, 2017, in payment of \$70,000 of the accrued consulting fees owed to Summit Management, the Company issued Summit Management 1,000,000 shares of the Company's common stock and a warrant to purchase 1,000,000 shares of the Company's common stock at an exercise price of \$0.10 per share.
