 - (4) On February 26, 2016, Mr. Hundt was granted 17,006 RSUs, one-fourth of which vested on the first anniversary of the date of grant, and the remaining three-fourths are vesting in equal installments on a quarterly basis over a three-year period thereafter.
 - (5) There is no expiration date with respect to the RSUs granted. Units will either vest or be forfeited.
