This award of RSUs was granted effective September 14, 2017, the date the stockholders of the Issuer approved the amendment and restatement of the Issuer's Amended and Restated 2009 Omnibus Equity Incentive Plan at the Issuer's 2017 annual meeting of stockholders. The award is scheduled to continue to vest over the original 36 monthly installment term with a vesting commencement date of July 21, 2017, subject to the terms of Mr. Coy's employment offer letter with the Issuer, dated January 11, 2013, as amended. The underlying shares of the RSUs are scheduled to settle by March 15 in the year after they vest.
