- (3) Includes 46,692 shares held by reporting person in custodial accounts.

The Performance (4) Share Rights vest upon achievement of specified thresholds of cumulative TSR compared to certain peers. Vesting will occur in three annual installments commencing March 8, 2014 through March 8, 2016.
