- (2) Pursuant to Ms. Perelman's 11/16/18 amended and restated employment agreement, on such date, the reporting person was granted 73,986 time-based RSUs under the Fourth Amended and Restated Revlon, Inc. Stock Plan. One-third of the time-based RSUs vest on each of 3/15/2019, 3/15/2020 and 3/15/2021 and will be settled as soon as practicable thereafter.
