- (2) Shares of Class A Stock were disposed of by the Reporting Person pursuant to a 10b5-1 trading plan entered into on December 16, 2015.
- (3) The transaction was executed in multiple trades at prices ranging from \$34.0000 to \$34.8400. The price reported above reflects the weighted average sales price.

- (7) The LLC Interests are redeemable for an equal number of shares of Class A Stock or, at the election of the Issuer, cash equal to the volume-weighted average market price of such shares. The LLC Interests have no expiration date.
