- On February 23, 2010, the Compensation Committee of the Company's Board of Directors awarded the reporting person performance based restricted stock units. - (5) following at least 5 years of service with Danaher and reaching the age of 55, or, if earlier, one-tenth per year of participation following five years of participation, in each case in accordance with the plan. Upon termination of employment, the vested portion of the EDIP Stock Fund is settled in Danaher common stock.
