- (10) Phantom Stock Units held for the benefit of reporting person as of September 30, 2012 based on the value of Humana common stock on a 1-for-1 basis, under the Humana Excess Plan. 1 share was acquired for a quarterly allocation of dividends under the Plan using the closing price of the dividend payable date on July 27, 2012. (The number of units reflect normal fluctuation due to changes in the stock price)
