As a result of the approval of the 2007 Plan, no additional awards will be made under the 1998 Plan, and 53,000,000 of the Common Shares that were available on April 23, 2007 for new grants under the 1998 Plan are now issuable under the 2007 Plan. Pursuant to Instruction E to Form S-8 and interpretations of the Staff of the SEC's Division of Corporation Finance, 52,999,999 of the unissued Common Shares previously registered and available for issuance under the 1998 Plan as of April 23, 2007 under Registration Statement No. 333-98479 are being carried forward and deemed covered by the registration statement on Form S-8 with respect to the 2007 Plan that was filed on the date hereof. An aggregate registration fee of \$211,393 was paid in connection with the filing of Registration Statement No. 333-98479, of which \$172,366 related to the 52,999,999 Common Shares being carried forward.
