Explanation of Responses:

(1) One-third of these options will vest on each of the first three anniversary dates of the grant. These options were acquired under Entergy's Equity Ownership Plan.

(2) These represent restricted phantom stock units under the Company's 2000-2002 Long Term Incentive Plan. On January 30, 2003 the Personnel Committee of the Board declared a pay-out of 10,200 units to the filing individual, who chose to receive the value of the units in cash.

(3) A duplicate of this Form was filed timely with the SEC yesterday, February 3, 2003.
