(1) On March 17, 2014, the reporting person exercised 10,000 stock options, delivered 3,722 shares of Common Stock of the Company for cancellation in payment of the exercise price of such options, and had 2,451 shares of Common Stock of the Company withheld and cancelled to cover minimum required tax withholding.
