Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote FOR the listed nominees and FOR Proposals 2, 4 and 5, and for "1 Year" on Proposal 3.

1. The election of Lawrence Anderson, M.D., Melvin B. Lovelady, CPA, John Sammons, William Sheehy and Preston L. Smith as members of the Board of Directors of the Company to serve until the Annual Meeting of Shareholders in 2020. The election of Michael Bosworth as a member of the Board of Directors of the Company to serve until the Annual Meeting of Shareholders in 2019. The election of Tony Morgan, CPA as a member of the Board of Directors of the Company to serve until the Annual Meeting of Shareholders in 2018.
2. A non-binding advisory vote on the compensation of the Company's named executive officers.
3. A non-binding advisory vote on the frequency at which the Company should include an advisory vote on the compensation of the Company's named executive officers in its proxy statement for shareholder consideration.
4. The Southside Bancshares, Inc. 2017 Incentive Plan.
5. Ratify the appointment by our Audit Committee of Ernst & Young LLP to serve as the independent registered public accounting firm for the Company for the year ended December 31, 2017.
