#### COMMON STOCK CASH DIVIDEND

JOHNSTOWN, PA AmeriServ Financial, Inc. (NASDAQ: ASRV) announced that its Board of Directors declared a \$0.01 per share quarterly common stock cash dividend. The cash dividend is payable February 22, 2016 to shareholders of record on February 8, 2016. This cash dividend represents a 1.3% annualized yield using the January 22, 2016 closing common stock price of \$3.16 and represents an approximate payout ratio of 14% based upon the Company s recently reported fourth quarter 2016 earnings per share of \$0.07.

AmeriServ Financial, Inc. is the parent of AmeriServ Financial Bank and AmeriServ Trust and Financial Services Company in Johnstown. The Company is subsidiaries provide full-service banking and trust and wealth management services through seventeen community offices in southwestern Pennsylvania.
