Mr. Freyberger's Agreement provides for the employment and retention of Mr. Freyberger as Chief Financial Officer for a one-year term subject to automatic one-year extensions. The Agreement increases Mr. Freyberger's (i) base salary to \$335,000 per annum and his annual bonus target to 100% of base salary, and (ii) his severance payment if he is terminated by the Company for reasons other than a change in control or cause to two times his annual base salary. The foregoing summary of the Agreement is qualified in its entirety by the Agreement, which is attached hereto as Exhibit 10.1 and incorporated by reference herein.
