Deregistration of Securities

This post-effective amendment relates to Registration Statement No. 033-52069 on Form S-8 of Old Republic International Corporation (the “Company”), which registered shares of Company Common Stock, par value \$1.00 per share, issuable pursuant to the Great West Casualty Company Profit Sharing Plan (the “Registration Statement”).

Effective as of January 1, 2014, the Great West Casualty Company Profit Sharing Plan was merged into the Company’s Baseline Security Plan and the offering of securities pursuant to the Registration Statement terminated.

In accordance with undertakings made by the Company in the Registration Statement to remove from registration, by means of a post-effective amendment, any of the securities registered pursuant to the Registration Statement that remain unsold at the termination of the offering, the Company hereby removes from registration all Common Stock registered under the Registration Statement but not sold under the Registration Statement as of the filing date of this post-effective amendment.
