- (1) Shares equivalent to the amounts required to satisfy payroll tax withholdings are withheld from distribution to recipient upon vesting of stock award, reducing the vested amount from 27,500 to 17,670 shares. There is no sale of shares.
The shares of restricted stock will remain subject to a repurchase right of Geron over four years, during such time the repurchase right will lapse with respect to 25% of such shares on each anniversary date of the date of grant. The lapse of Geron's repurchase right is conditioned on the employee continuing to provide services to Geron through each vesting date.
- (3) This option is exercisable in a series of 48 equal monthly installments commencing May 28, 2008, provided the optionee continues to provide services to the Company.
- (4) This option is exercisable in a series of 24 equal monthly installments commencing September 18, 2008, provided the optionee continues to provide services to the Company.
