This prospectus supplement relates to the resale by the holders of Amkor Technology, Inc. 5% Convertible Subordinated Notes due 2007 and the shares of common stock, \$0.001 par value per share, issuable upon the conversion of the Convertible Notes.

This prospectus supplement should be read in conjunction with, and may not be delivered or utilized without, the prospectus dated September 7, 2000, including the supplements dated September 8, 2000, September 27, 2000, November 2, 2000, December 4, 2000, January 12, 2001, January 29, 2001, March 9, 2001, April 20, 2001, June 4, 2001, August 16, 2001 and November 5, 2001 and any other amendments or supplements thereto. The terms of the Convertible Notes are set forth in the prospectus.
