Mexico City, March 13, 2006--Grupo Televisa, S.A. ("Televisa"; NYSE:TV;  
BMV:TLEVISAS CPO), today issued the following statement:

In response to press reports regarding Televisa's potential involvement in  
the process announced by Univision on February 8, 2006, we are in the early  
stages of analyzing different alternatives to determine what, if any,  
course of action makes sense for us. At this point, we are not  
participating in the process, and we have had no discussions or  
negotiations with Univision. In addition, we have no agreements with any  
third party to form a group or consortium.

Grupo Televisa, S.A., is the largest media company in the Spanish-speaking  
world and a major participant in the international entertainment business.

Grupo Televisa also owns an unconsolidated equity stake in Univision, the leading Spanish-language media company in the United States.
