Item 8.01 Other Events

On August 26, 2015, Tony Bartholomew, Senior Vice President of Professional Sales of O'Reilly Automotive, Inc. (the "Company"), established a plan in accordance with Rule 10b5-1 of the Securities Exchange Act of 1934, as amended, for the trading of the Company's common stock. The plan provides for option exercises and subsequent sales of specified share amounts at specific market prices, subject to specified limitations. The plan was established for the purpose of facilitating the exercise and subsequent sale of stock options with a ten-year contractual life that are due to expire in July of 2018. The plan was established during the Company's unrestricted trading window and at a time when Mr. Bartholomew was not in possession of material, non-public information about the Company. Mr. Bartholomew has informed the Company that he will publicly disclose, as required by federal securities laws, any option exercises and stock sales made under this plan.
