MetLife distributed 96,776,670 of the 119,773,106 outstanding shares of Brighthouse Financial, Inc. common stock at 5:00pm, New York City time, on August 4, 2017. Of the shares MetLife distributed, 157,665 were received by accounts in which MetLife has a direct pecuniary interest; the balance of MetLife's direct ownership following the distribution consists of the 22,996,436 shares MetLife did not distribute. In addition, 1,016 of the shares MetLife distributed were received by accounts in which MetLife has an indirect pecuniary interest.
