EXPLANATORY NOTE

Infogroup Inc. (the “Company”) filed a Registration Statement on Form S-8 (No. 333-77417) (the “Registration Statement”) with the Securities and Exchange Commission on April 30, 1999. On July 1, 2010, pursuant to that certain Agreement and Plan of Merger, dated as of March 8, 2010, by and among the Company, Omaha Holdco Inc., a Delaware corporation (“Parent”), and Omaha Acquisition, Inc., a Delaware corporation, the registrant became a wholly-owned subsidiary of Parent. As a result of the transactions contemplated thereby, the Company has terminated all offerings of the Company’s securities pursuant to the Registration Statement.

This Post-Effective Amendment No. 1 to the Registration Statement is being filed to deregister, as of the effectiveness of this post-effective amendment, all unsold securities which were registered for sale under the Registration Statement.
