- David Bonderman and James G. Coulter are officers and sole shareholders of TPG Group Holdings (SBS) Advisors, Inc. ("Group Advisors" and, together with Messrs. Bonderman and Coulter, the "Reporting Persons"), which is the general partner of TPG Group Holdings (SBS), L.P., which is the sole member of TPG Holdings I-A, LLC, which is the general partner of TPG Holdings I, L.P., which is the sole member of TPG Biotechnology GenPar Advisors, LLC, which is the general partner of TPG Biotechnology GenPar, L.P., which is the general partner of each of TPG Biotechnology Partners, L.P. ("TPG Biotechnology") and TPG Biotech Reinvest AIV, L.P. ("TPG Biotech Reinvest" and, together with TPG Biotechnology, the "TPG Funds").
- (1) TPG Biotechnology directly holds 1,000,000 shares of Series A-1 Preferred Stock (the "Series A-1 Preferred") of Aerie Pharmaceuticals, Inc. (the "Issuer"), 5,000,000 shares of Series A-2 Preferred Stock (the "Series A-2 Preferred") of the Issuer and 10,864,738 shares of Series A-3 Preferred Stock (the "Series A-3 Preferred") of the Issuer.
 - (2) TPG Biotech Reinvest directly holds 1,111,831 shares of Series B Preferred Stock (the "Series B Preferred") of the Issuer.
 - (3) Because of the relationship between the Reporting Persons and the TPG Funds, the Reporting Persons may be deemed to beneficially own the securities reported herein to the extent of the greater of their respective direct or indirect pecuniary interests in the profits or capital accounts of the TPG Funds. Each Reporting Person and each of the TPG Funds disclaims beneficial ownership of the securities reported herein, except to the extent of such Reporting Person's or such TPG Fund's pecuniary interest therein, if any.
 - (4) Pursuant to Rule 16a-1(a)(4) under the Securities Exchange Act of 1934, as amended (the "Exchange Act"), this filing shall not be deemed an admission that the Reporting Persons are, for purposes of Section 16 of the Exchange Act or otherwise, the beneficial owners of any equity securities in excess of their respective pecuniary interests.
 - (5) Pursuant to the Third Amended and Restated Certificate of Incorporation of the Issuer, the shares of Series A-1 Preferred, Series A-2 Preferred, Series A-3 Preferred and Series B Preferred are convertible, at the option of the holder, at any time into shares of Common Stock, par value \$0.001 per share, of the Issuer, at initial conversion rates in each case equal to 1 share of Common Stock per share of preferred stock. The initial conversion rates have been adjusted as a result of a 1-for-5 reverse stock split of the Issuer's Common Stock.
