("Master Fund"), a Cayman Islands company of which the investment manager is Perceptive Advisors LLC, a Delaware limited liability company of which Mr. Edelman is the managing member and (ii) bonds convertible into 300,480 shares held personally by Mr. Edelman.
- (b) Percent of class:  
The beneficial ownership of 11.2% is based on the sum of (i) 78,151,727 shares issued and outstanding as of December 1, 2008 as reported on the Issuer's 10-K as filed with the SEC on December 11, 2008, (ii) bonds convertible into 3,046,875 shares held by the Master Fund, and (iii) bonds convertible into 300,480 shares held personally by Mr. Edelman.
