On November 15, 2007, United Community Bancorp (the "Company") announced the completion of its previously disclosed stock repurchase program under which it acquired 190,440 shares of its common stock. The Company also announced that its Board of Directors has authorized a new stock repurchase program under which the Company will repurchase up to 180,918 shares of the Company's outstanding common stock, or approximately 5% of outstanding shares held by persons other than United Community MHC. The press release announcing the completion and authorization of the stock repurchase programs is filed as Exhibit 99.1 and incorporated herein by reference.
