As of February 20, 2003, 143,520 shares of Preferred Stock, or 5.7% of the total outstanding shares of Preferred Stock on that date, were held by KSC Ltd.

KSC Ltd. may be deemed to have shared voting and dispositive power over the 143,520 shares of Preferred Stock it owns, or 5.7% of the total outstanding shares of Preferred Stock.

KSCM:

Because KSCM is the investment adviser to KSC Ltd. pursuant to Rule 13d-1, as of February 20, 2003, KSCM may be deemed to be the beneficial owner of 143,250 shares of Preferred Stock, or 5.7% of the total outstanding shares of Preferred Stock on that date, consisting of the shares owned by KSC Ltd.

Because of the relationship described above, KSCM may be deemed to have shared voting and dispositive power over the 143,250 shares of Preferred Stock, or 5.7% of the total outstanding shares of Preferred Stock.

O. Francis Biondi, Jr.:

Because Mr. Biondi is a managing member of both KSCM and King Street Advisors, L.L.C., the general partner of King Street Capital L.P. ("KSC L.P."), a Delaware limited partnership over which it exercises investment discretion and which may be deemed to be the beneficial owner of additional outstanding shares of Preferred Stock, pursuant to Rule 13d-1, as of February 20, 2003, Mr. Biondi may be deemed to be the beneficial owner of 220,800 shares of Preferred Stock, or 8.8% of the total outstanding shares of Preferred Stock on that date, consisting of the shares owned by KSC L.P. and KSC Ltd.

Because of the relationship described above, Mr. Biondi may be deemed to have shared voting and dispositive power over an aggregate of 220,800 shares of Preferred Stock, or 8.8% of the total outstanding shares of Preferred Stock, consisting of shares owned by KSC L.P. and KSC Ltd.

Brian J. Higgins:

Because Mr. Higgins is a managing member of both KSCM and King Street Advisors, L.L.C., the general partner of King Street Capital L.P. ("KSC L.P."), a Delaware limited partnership over which it exercises investment discretion and which may be deemed to be the beneficial owner of additional outstanding shares of Preferred Stock, pursuant to Rule 13d-1, as of February 20, 2003, Mr. Higgins may be deemed to be the beneficial owner of 220,800 shares of Preferred Stock, or 8.8% of the total outstanding shares of Preferred Stock on that date, consisting of the shares owned by KSC L.P. and KSC Ltd.

Because of the relationship described above, Mr. Higgins may be deemed to have shared voting and dispositive power over an aggregate of 220,800 shares of Preferred Stock, or 8.8% of the total outstanding shares of Preferred Stock, consisting of shares owned by KSC L.P. and KSC Ltd.

Because of the relationships described above, the Reporting Persons may be deemed to constitute a "group" within the meaning of Rule 13d-5 under the Securities and Exchange Act of 1934, and as such, each member of the group would be deemed to beneficially own, in the aggregate, all of the shares of the Preferred Stock held by members of the group. The Reporting Persons do not admit that they constitute a group within the meaning of Rule 13d-5.
