(a) and (b) Based upon an aggregate of 5,224,282 shares of Common Stock outstanding, as determined by the Issuer's most recently available public information, as of the close of business on November 13, 2012:

- (i) MHFII beneficially owned 287,100 shares of Common Stock, constituting approximately 5.50% of the shares outstanding.
- (ii) Holdings owned directly no shares of Common Stock. By reason of its position as general partner of certain partnerships, Holdings may be deemed to beneficially own the 343,000 shares of Common Stock, which are held by such partnerships, constituting approximately 6.57% of the shares outstanding.
- (iii) SOAM owned directly no shares of Common Stock. By reason of its position as investment advisor, SOAM may be deemed to beneficially own the 450,600 shares of Common Stock, which are held of record by clients of SOAM, constituting approximately 8.63% of the shares outstanding.
- (iv) Mr. Maltese directly owned no shares of Common Stock. By reason of his position as Managing Member of SOAM, Mr. Maltese may be deemed to beneficially own 450,600 shares of Common Stock, constituting approximately 8.63% of the shares outstanding.
