(a-e) As of the date hereof, Fairholme may be deemed to be the beneficial owner of 27,002,485 Shares (40.5%) of the Issuer, the Fund may be deemed to be the beneficial owner of 23,636,502 Shares (35.4%) of the Issuer and Mr. Berkowitz may be deemed to be the beneficial owner of 27,002,485 Shares (40.5%) of the Issuer, based upon the 70,432,071 Shares outstanding as of July 31, 2017, according to the 10-Q filed by the Issuer on August 3, 2017, minus the 3,742,111 Shares repurchased by the Issuer according to the 8-K filed by the Issuer on September 21, 2017. Of the 23,636,502 Shares deemed to be beneficially owned by the Fund, 23,136,502 are owned by the Fairholme Fund and 500,000 are owned by The Fairholme Allocation Fund, each a series of the Fund.

Fairholme has the sole power to vote or direct the vote of 0 Shares, the Fund has the sole power to vote or direct the vote of 0 Shares and Bruce R. Berkowitz has the sole power to vote or direct the vote of 0 Shares to which this filing relates. Fairholme has the shared power to vote or direct the vote of 24,210,302 Shares, the Fund has the shared power to vote or direct the vote of 23,636,502 Shares and Mr. Berkowitz has the shared power to vote or direct the vote of 24,210,302 Shares to which this filing relates.
