INDEPENDENT AUDITOR'S REPORT

We have examined management's assertion about Franklin Capital Corporation's (the "Company's") compliance with the requirements of subsections (b) and (c) of Rule 17f-2 under the Investment Company Act of 1940 ("the Act") as of December 29, 2000 included in the accompanying Management Statement Regarding Compliance with Certain Provisions of the Investment Company Act of 1940. Management is responsible for the Company's compliance with those requirements. Our responsibility is to express an opinion on management's assertion about the Company's compliance based on our examination.

Our examination was made in accordance with standards established by the American Institute of Certified Public Accountants and, accordingly, included examining, on a test basis, evidence about the Company's compliance with those requirements and performing such other procedures as we considered necessary in the circumstances. Included among our procedures were the following tests performed as of December 29, 2000, and with respect to agreement of security purchases and sales, for the period from September 28, 2000 (the date of our last examination) through December 29, 2000.

- o Count and inspection of all securities located in the vault of The Bank of New York, 575 Madison Avenue, New York, NY 10022 with prior notice to management.
- o Confirmation of all such securities out for transfer with brokers;
- o Reconciliation of all such securities to the books and records of the Company;
- o Agreement of 40 security sales and 4 security purchases since our last report from the books and records of the Company or the broker confirmations.

We believe that our examination provides a reasonable basis for our opinion. Our examination does not provide a legal determination on the Company's compliance with the specified requirements.
