- The 150,000 shares were pledged in 1997 by Ms. Shogen to secure a loan and the lender is now claiming that such shares were transferred by Ms. Shogen to the lender in February 2003. Ms. Shogen denies that such transfer took place and has filed a lawsuit against
- (1) the lender to resolve this dispute. However, since the lender is alleging that the shares were transferred, Ms. Shogen is filing this Form 4 to reflect the alleged transfer. Ms. Shogen is vigorously maintaining the position that this does not reflect the transfer of shares. If Ms. Shogen is successful in her lawsuit she will file an amendment to this Form 4.
