- (1) On February 25, 2008, Reporting Person was granted 4,320 (target) performance-based restricted stock units ("PBRUs") pursuant to the Issuer's 2006 Long-Term Incentive Plan. On February 28, 2011, the Compensation Committee determined that the level of performance achieved entitled the holders of the PBRUs to 54% of their target award. Accordingly, on February 28, 2011, the PBRUs vested and converted into the number of shares set forth in this Form 4.
