(2) On March 15, 1988, 74,398 shares previously owned through the Smith International, Inc. 401(k) plan were rolled over into a self-directed IRA. On June 20, 2002, the common stock of Smith International, Inc. split 2-for-1, resulting in the reporting person's acquisition of 126,217 additional shares of common stock.

(3) On June 20, 2002, the common stock of Smith International, Inc. split 2-for-1, resulting in the reporting person's deemed acquisition of 152,736 additional shares of common stock.
