	(a)	(a) This statement is filed on behalf of Southwell Partners, L.P. ( <u>Southwell</u> ). On January 11, 2006, Southwell filed a Schedule 13G stating that its ownership percentage was 4.7% and, as such, its beneficial ownership was less than five percent of the Issuer. Accordingly, Southwell s reporting obligations under Section 13 of the Securities Exchange Act of 1934 ceased. Southwell subsequently purchased additional shares of the Issuer, which on January 19, 2006 increased its ownership percentage above five percent of the Issuer. As of January 27, 2006, Southwell was the record holder of 150,000 shares of common stock of the Issuer. In addition, Southwell is the record holder of a					

convertible promissory note of the Issuer (the <u>Note</u>) convertible into an aggregate of 904,110 shares of common stock. Pursuant to the terms of the Note, the number of shares of common stock that Southwell may acquire upon conversion of the Note is limited to that number of shares of common

Southwell at the time of such conversion, would not exceed 9.99% of the total number of issued and outstanding shares of common stock, calculated in accordance with Section 13(d) of the Securities Exchange Act of 1934. Accordingly, as of January 19, 2006, Southwell was also the beneficial owner of 1,054,110 shares of common stock issuable upon partial conversion of the Note.
